Agora Regeneration Project – Construction works St Georges Way

I would like to take this opportunity to introduce myself. My name is Samantha Swain and I am the Resident Liaison Officer for GRAHAM Construction, the Principal Contractor working with Milton Keynes City Council on the Agora Regeneration Project.

We would like to inform you that construction works in St Georges Way (Phase 1 of the Agora Project) are scheduled to commence on 18 May 2026, with completion anticipated in December 2026.

The scope of works will include:

- Demolition of the garages located behind 31–36 St Georges Way
- Excavation of existing roads and parking areas
- Installation of new hard and soft landscaping in line with the approved plans

To facilitate these works, the construction areas will be securely fenced off, with hoarding installation beginning from 18 May. Access to your front door and emergency escape routes will be maintained throughout the works. However, during paving works directly outside properties, some temporary disruption to access is unavoidable. We will provide advance notice ahead of these activities.

Please note that **all vehicles must be removed from existing parking spaces during the week commencing 18 May 2026**. A reminder that alternative parking is available as per letter from MKCC.

We appreciate your patience and understanding while these works are carried out. We are committed to keeping you informed and minimising disruption wherever possible. Should you have any concerns or require assistance, please do not hesitate to get in touch.

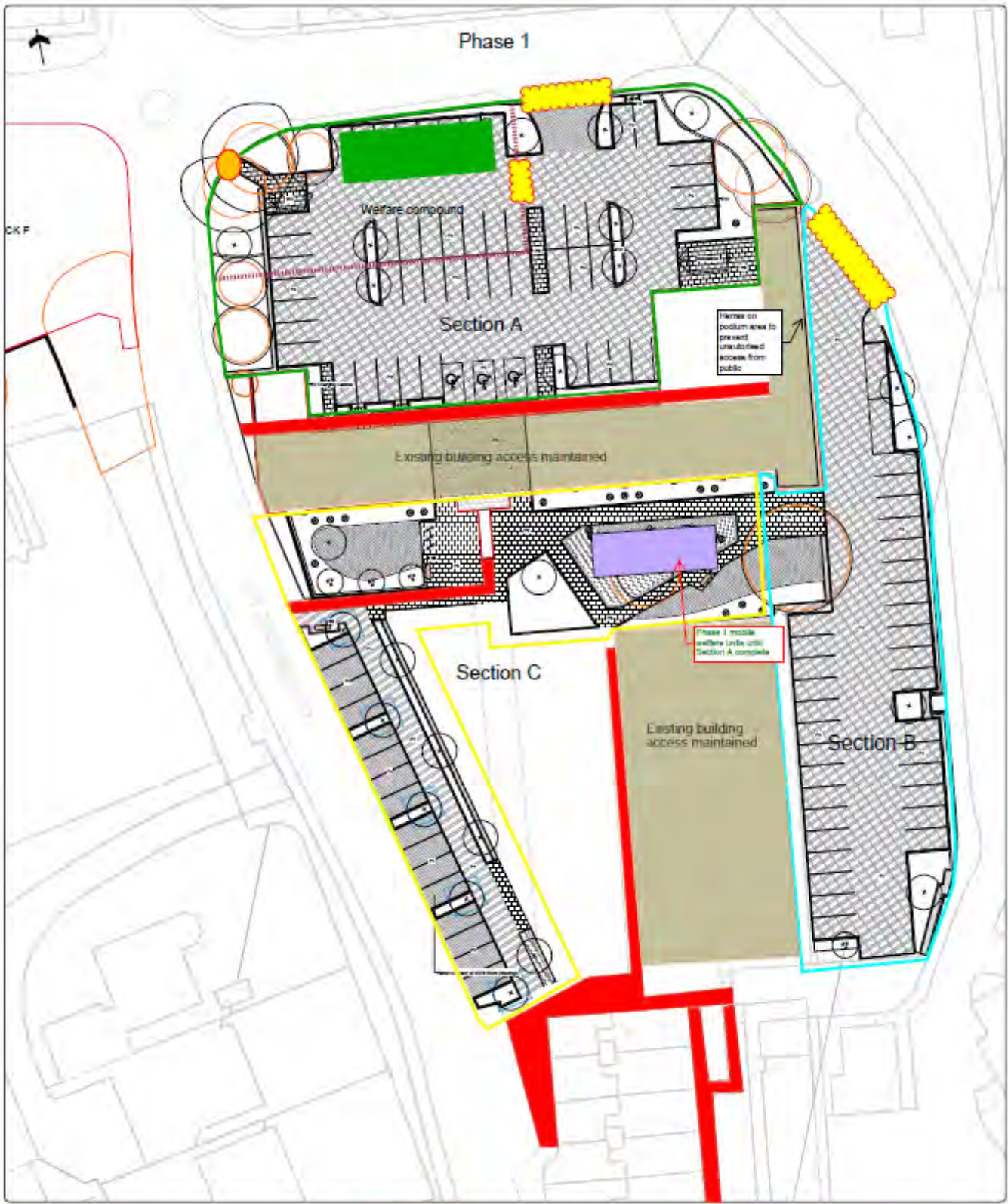
